Submittal of Parts Manufacturer Approval Minor Changes

Dear PMA Applicant/Holder:

As noted on your approved Parts Manufacturer Approval (PMA) Supplement, you are required to submit minor changes to the FAA in a manner determined acceptable to the FAA Aircraft Certification Office (ACO) responsible for the design. With the increased number of PMA projects and minor changes, it is becoming increasingly difficult for us to review and provide a written response approving the minor changes in an expeditious manner. In an attempt to respond to your needs, we are requesting that you submit all minor change data/drawing packages to us with the following information:

- 1. A cover letter requesting approval of the minor changes and the reporting interval agreed to by the ACO. Most companies have established procedures with the ACO to submit their minor changes periodically. We recommend submittals should occur in six (6) month intervals.
- 2. A copy of the original ACO branch PMA design approval and PMA supplement that the data/drawing pertains to. Please note that the authority to review and concur engineering minor design changes for PMA by identicality under licensing agreement must be coordinated by the respective Type Certificate, Supplemental Type Certificate, or Technical Standard Order authorization holder. The ACO does not need to be involved on this type of submittal.
- 3. A separate list which contains all of the minor change data (drawings/Engineering Orders/Change Notices, etc.) with revision level, a description of each change and the respective PMA supplement number.
- 4. One copy of the drawings/EOs/Change Notices, etc. (Note: Drawings should be readable. If documents are larger than 8 ½ x 11", it is recommended these are folded to 8 ½ x 11".)

Once the data has been reviewed and we concur with the minor change classification, we will send back a letter or a copy of your summary list (drawings, EOs, change Notices, etc.) stamped with the FAA acceptance as evidence for your records. In accordance with 14 Code of Federal Regulations §§ 21.95 and 21.319(b), you may continue to produce parts after submitting minor changes based on the agreed schedule.
